HCW Returning from Travel in the EU, Iceland, Lichtenstein, Norway, Switzerland	If HCW has a negative RT-PCR result from a test taken within 72 hours prior to arrival into the country, HCW does not require quarantine and can attend work.	HCW does not require restricted movement or testing and can attend work. Travel restrictions for passengers arriving into Ireland from outside EU + Iceland, Liechtenstein, Norway, Switzerland (includes Great Britain)	You must present evidence of a negative result from a RT-PCR test taken within 72 hours prior to arrival into the country <u>Self-quarantine</u> for 14 days Can leave quarantine with a negative RT-PCR test taken from day 5 onwards	HCW does not require restricted movement or testing and can attend work. Proof of vaccination/ recovery must be in line with Government guidance <u>https://www.gov.ie/en/publication/77952-</u> <u>government-advice-on-international-</u> <u>travel/</u>
